

Ethical Guidelines for the *Jerusalem Quarterly* (JQ)



The *Jerusalem Quarterly* adheres to the industry standards for publishing ethics set forth by the Committee on Publication Ethics (COPE) and available online at <https://publicationethics.org/guidance/Guidelines>.

The *Jerusalem Quarterly* is dedicated to supporting the vast efforts of the editors, the academic contributions of authors, and the respected volunteer work undertaken by reviewers. The *Jerusalem Quarterly* is also responsible for ensuring that the publication system works smoothly, and that ethical guidelines are applied to assist the editor, author, and reviewer in performing their ethical duties.

In addition, some key points are listed below.

JQ's Editorial Committee maintains confidentiality and adheres to objectivity in the peer reviewing process. It adopts an anonymous peer review process, where the Editorial Committee selects the appropriate reviewer to assess paper suitability for publication, according to specific criteria. In case of a conflict between the reviewers regarding the publication's assessment, a third reviewer will be selected.

JQ relies on a pool of experienced peer reviewers who are up to date with the latest developments in their field.

JQ adopts a rigorous internal organization with clear duties and obligations to be fulfilled by the Editorial Committee.

Disclosure: With the exception of the Co-editors and the Executive Editor (or those standing in for the Editor), neither the editors, nor the peer reviewers, are allowed to discuss the manuscript with third parties, including the author. Information or ideas obtained in the course of the reviewing and editing processes must be kept confidential and cannot be used for personal gain.

When needed, based on the reviewer report, the Editorial Committee may offer researchers methodological, technical, and other assistance in order to improve the quality of their submissions.

JQ's editors commit to informing authors of the acceptance or otherwise of their manuscripts, based on the reviewers' report, or to notify authors in case of rejection, specifying the reasons for rejection.

Fairness: the editors and the reviewers evaluate manuscripts for their intellectual and scientific merit, without regard to race, ethnicity, gender, religious beliefs, or political views of the authors.

Conflict of interests: editors and peer reviewers should not consider manuscripts in which they have conflicts of interests resulting from competitive, collaborative, or other relationships or connections with any of the authors, companies, or institutions connected to the papers.

Confidentiality: unpublished data obtained through peer review must be kept confidential and cannot be used for personal research.

Intellectual property and copyright: JQ retains copyright to all articles published in its issues. The articles may not be published elsewhere fully or partially, in English or in another language, without an explicit written authorization from JQ.

JQ's Editorial Committee fully respects intellectual property when translating and publishing an article published in a foreign journal, and will not proceed before obtaining the authorization from the journal in question.

JQ is committed to providing quality professional copy editing, proof reading, and online publishing service.

JQ does not make payments for manuscripts published in the journal, and all authors and researchers are exempt from publication fees.
